BUSHFIRE FINANCIAL SUPPORT for small business and primary producers

\$10,000 small business bushfire support grant

These grants assist with the costs of maintaining businesses, including covering salaries, rent and utilities. To be eligible, small businesses and primary producers in Towong, East Gippsland and Alpine shires must have experienced a 40 per cent decline in revenue over a three-month period, compared to the previous year, as a result of the 2019/20 Victorian Bushfires. You may also be eligible under exceptional circumstances if you don't meet this criteria.

- This grant is available if you were directly or indirectly affected by bushfire.
- You are not required to upload financial documents if you don't have them right now.
- The grant application process is short and simple.
- You may apply if you have recieved other grants.

\$75,000 farm recovery grant

Available to eligible directly affected primary producers for costs of rebuilding. To apply, visit **ruralfinance.com.au**.

\$50,000 business recovery grant

Available to eligible directly affected small businesses to cover costs of rebuilding. Visit **business.vic.gov.au/bushfire-recovery**.

\$500,000 concessional loan

Available to eligible directly affected small businesses and primary producers. To apply, visit **ruralfinance.com.au**. You may still apply for this if you have recieved grants.

\$10,000 COVID-19 business support

You can still recieve this grant if you have recieved bushfire grants. It is available to small businesses who have been highly impacted by COVID-19 restrictions. Other criteria apply. To apply or see more, visit **business.vic.gov.au**.
