### Who develops this Training Plan?

This Training Plan is developed by Master Plumbers as the Registered Training Organisation (RTO), the employer and the apprentice.

It outlines who provides the training and assessment and how, when and where it occurs.

This Training Plan is a working document that can be amended as required. The Training Plan must be updated regularly during the Training Contract.

### What does this Training Plan record?

There are **three** parts.

**Part I** records relevant details of the parties responsible under the Training Contract.

It shows the proposed time line for the qualification.

**Part II** records the delivery and assessment arrangements for the qualification.

It also shows suggested points of employer contact.

At these points Master Plumbers will consult with the employer to gather feedback on the workplace performance and competency achievement of the apprentice.

**Part III** verifies that the apprentice has satisfied all the requirements of the qualification and the employer has completed all the employer has returned written confirmation of the apprentice's competence as an employee in the workplace to the RTO.

### Grouping of units

The Training Plan will group units together in projects that reflect typical industry work tasks and practices and the delivery strategy developed for the apprenticeship.

At each contact point employers will provide feedback on the performance of the apprentice in these tasks in the workplace.

### Competency Based Training

Competency in the plumbing industry is having plumbing specific knowledge and skills and being able to demonstrate that knowledge and skill consistently over time in the workplace.

This Training Plan is designed to focus on the apprentice gaining the knowledge and skills to the standard performance required by industry as detailed in the qualification.

Competency based training and completion allows apprentices to move through their apprenticeship as they attain competencies rather than by serving time.

### Responsibilities

**The apprentice/trainee's responsibilities include, but are not limited to:**

- Jointly selecting the RTO with the employer
- Contributing towards the development of the Training Plan
- Attending work, doing their job, and following the employer's instructions, as long as these are lawful
- Working towards achieving the stated qualification
- Undertaking all training and assessment contained in this Training Plan
- Liaising with the RTO and employer to determine the achievement of competence in required skills

**The employer's responsibilities include, but are not limited to:**

- Jointly selecting the RTO with the apprentice
- Contributing towards the development of the Training Plan
- Providing on-job skill development
- Maintaining training records
- Providing the apprentice with feedback on progress
- Liaising with the RTO and apprentice to determine the achievement of competence in required skills

#### Information about Competency Based Completion

*As of 1 January 2011, all plumbing apprenticeships in Victoria operate as Competency Based Completion (CBC). Please note these dates refer to the date training commenced with a Registered Training Organisation (RTO) and not the commencement date of the training contract. This means all apprentices are able to complete their training at their own pace, without being locked into a fixed time period. The rate they progress through their apprenticeship is determined by demonstrating they have met competency-based standards through their training program and related work, not by the time they spend in training.*

*The apprenticeship is completed when all the competencies of the structured training have been achieved **and** the employer has returned written confirmation of the apprentice's competence as an employee in the workplace to the RTO.*

*Completion may be formalised by the joint signing off on the training plan.*

*RTOs must ensure that clear advice has been provided to the employer that this confirmation completes the training contract for an apprenticeship. When the RTO has received the confirmation from the employer, the RTO will enter the information into the apprenticeship database known as Epsilon.*

*The VRQA will then write to both the employer and the apprentice confirming that the apprenticeship is completed.*
